In signing this application, I verify that I have boating liability insurance in the amount of \$100,000. Entry forms that are not completed in full and signed by both parties will not be accepted.

Anglers in Action Team Trail: Membership fee is \$50.00 per season, per angler. Entry fee is \$140.00 per qualifying tournament and \$200 for each Shootout. You may include a \$20 deposit per tournament to reserve your boat number. Membership fee must be paid before fishing any tournament event. Reservation money will not be refunded unless the tournament is officially canceled. Boat position will transfer forward in the event of a rescheduled tournament.

The undersigned acknowledge that there is a significant risk of injury from the activities involved in the Tournament including the potential for permanent injury and death. The undersigned agree that they are knowingly and freely assuming all risks of participation in the Tournament and assume full responsibility for their participation in the Tournament.
